<b><u>Initiation Fee Payment</u></b>	New members must pay a minimum of 25% of initiation fee upfront. Balance may be spread out over 4 payments in the first year.				
<b><u>Social Sports Membership</u></b>	Full access to all social events, dining, pool, tennis, pickleball, driving range (extra fee) and golf, four (4) rounds per year at family guest rate—\$45 per player excluding cart fee.				
<b><u>Single Status</u></b>	A membership held by an unmarried individual age 21 years or older.				
<b><u>Immediate Family</u></b>	Immediate family can enjoy all Club facilities in accordance with category of membership. Immediate family includes spouse, significant other and unmarried dependent children 23 years old or younger. The age of the oldest family member, regardless of gender, determines the dues classification of all memberships.				
<b><u>Capital Reserve Fund Fee</u></b>	A monthly fee of \$70 is included in all monthly dues to establish a reserve for future large capital projects; may be subject to change.
